- Article 4 Environmental objectives

National experiences

- Water Services are not defined yet;
- Main document for implementation of the resources cost policy is Regulation on water fees (annually);

REGULATION ON FEES FOR WATER IN 2016

- Fee for water resources use
 - Fee for water use
 - Fee for the water lands use
- Fee for discharged water
- Fee for drainage
- Fee for the use of water structures and multifunctional water systems

Fee for water use

- Raw water for industrial objects
- Drinking water quality
- Irrigation
- Aquaculture (fishery)
- Drinking water quality distributed to public water supply companies and other legal entities
- Thermal water exploitation
- Mineral and natural water etc.

Fee for the water lands use

- Sand and gravel extraction;
- Economic activities (different types of storages);
- Other economic activities (coal manipulation activities, fishery, intakes for industry, etc.)
- Recreational use, sports and tourism;

Fee for Water Discharge

- Industrial and other waste water;
- Municipal waste water;
- Cooling waste water;

Increase of the fee of 50% is implemented when the discharge point is in the protection zones;

- Discharge in public sewage systems

Fee for Drainage

- Drainage from agricultural land;
- Drainage from forest land;
- Drainage from building land;

Fee for use water structures and multy-functional water systems

- Use of melioration systems (Vojvodina) for:
 - Water use
 - Irrigation
 - Water discharge in canals
